# **Epocast® 1618 D/B Epoxy Syntactic**

#### **DESCRIPTION**

Epocast<sup>®</sup> 1618 D/B epoxy syntactic is a low-density, flame retardant compound for potting fasteners in honeycomb structures. The lightweight epoxy is easy to extrude through a 1/8 in (3 mm) nozzle orifice, but is non-flowing after application. Epocast<sup>®</sup> 1618 D/B epoxy syntactic sets quickly at room temperature and is qualified to BMS 5-28, Type 18, Class 1. It is the suggested alternative for the discontinued Epocast<sup>®</sup> 1616 A/B epoxy syntactic, Epocast<sup>®</sup> 1618 A/B epoxy syntactic, and Epocast<sup>®</sup> 1620 A/B epoxy syntactic systems.

### **MIX RATIO**

To 100 parts by weight of Epocast<sup>®</sup> 1618 D resin, add 14 parts by weight of Epocast<sup>®</sup> 1618 B hardener. Mix both components thoroughly for several minutes to assure complete blending.

### **CURE SCHEDULE**

24 hours at room temperature or gel at room temperature plus five hours at 125°F (52°C).

### **STORAGE**

Epocast<sup>®</sup> 1618 D/B should be stored in a dry place, in the sealed original container, at temperatures between +2°C and +40°C (+35.6°F and 104°F). The product should not be exposed to direct sunlight. Under these storage conditions, and when supplied under Huntsman standard certification, this product has a shelf life of 6 months from date of shipment (expiration date may differ based on customer specification).

Material temperatures should be above 18°C (65°F) when mixing. After use, tightly reseal containers.
