MIX RATIO:

To 100 parts by weight of Epocast[®] 169A-1 resin, add 50 parts by weight of Hardener 9615. Mix both components thoroughly for 3-5 minutes to insure complete and uniform mixing.

CURE SCHEDULE:

3 days at 75°F \pm 5°F (23°C \pm 3°C), or room temperature gel plus 2 hours at 150°F \pm 10°F (66°C \pm 6°C).

STORAGE:

Epocast[®] 169A-1 Resin/9615 Hardener should be stored in a dry place, in the sealed original container, at temperatures between +2°C and +40°C (+35.6°F and 104°F). The product should not be exposed to direct sunlight. Under these storage conditions, and when supplied under Huntsman standard certification, this product has a shelf life of 1 year (expiration date may differ based on customer specification).

Material temperatures should be above 18°C (65°F) when mixing. After use, tightly reseal containers.
