#### **DESCRIPTION:**

Epocast<sup>®</sup> 169A-1 resin with 9646 Hardener epoxy syntactic is a low-density foam which cures at room temperature to a carvable, woodlike product. The epoxy syntactic has good dimensional stability under changing humidity conditions and is pourable for easier application as a core fill and honeycomb reinforcement. Epocast<sup>®</sup> 169A-1 resin can also be used with 9646-A Hardener at the same mix ratio, to produce a non-flow paste consistency.

#### **MIX RATIO:**

To 100 parts by weight of Epocast<sup>®</sup> 169A-1 resin, add 35 parts by weight of 9646 hardener. Mix both components thoroughly for 3 - 5 minutes to insure complete and uniform mixing.

#### **CURE SCHEDULE:**

24 hours at 75°F ± 5°F (24°C ± 2°C), or room temperature gel plus 2 hours at 150°F ± 10°F (66°C ± 5°C).

### STORAGE:

Epocast<sup>®</sup> 169A-1 Resin with 9646 Hardener should be stored in a dry place, in the sealed original container, at temperatures between +2°C and +40°C (+35.6°F and 104°F). The product should not be exposed to direct sunlight. Under these storage conditions, and when supplied under Huntsman standard certification, this product has a shelf life of 1 year (expiration date may differ based on customer specification).

Material temperatures should be above 18°C (65°F) when mixing. After use, tightly reseal containers.
